Notes on Contributors

Deane-Peter Baker

teaches at UNSW Canberra, the part of the University of New South Wales (UNSW Australia) that delivers undergraduate education to the trainee officers and officers in training of the Australian Defence Force Academy. The main focus of his research and teaching is on military ethics, though he also works on other issues in applied ethics, public policy, as well as on issues in military strategy and operations. His most recent book is *Citizen Killings: Liberalism, State Policy and Moral Risk* (Bloomsbury 2016).

Michael D. Beaty

is Professor and Chair of Philosophy at Baylor University (Waco, TX). His scholarship primarily considers questions in moral philosophy, philosophy of religion, and Christian Higher Education.

received her BSc in Psychology (University of Twente) in 2014 and her MA in Criminology (University of Utrecht) in 2016.
