Preface

The volume contains selected, peer-reviewed papers from Topical Issues of Linguistics and Teaching Methods in Business and Professional Communication (TILTM 2022), 22-23 April, 2022, Peoples' Friendship University of Russia (RUDN University), Russia.

The objective of the conference was to highlight new trends and ideas in the sphere of the English Language of Business Communication.

The present volume reflects the participants' ideas on a wide range of up-to-date concerns related to both the contemporary vector of scientific development and the issues arising due to the trend towards on-line learning combined with off-line training. The speakers put particular emphasis on the necessity to adapt the habitual educational modes to today's challenges, and suggested their vision of recommended or desirable teaching methods and materials.

X International research conference Topical Issues of Linguistics and Teaching Methods in Business and Professional Communication was held by the Foreign Languages Department of the Faculty of Economics. The conference was supported by: Glasgow Caledonian University (UK), University of Rome Tor Vergata (Italy), The University of Salamanca (Spain), Nuh Naci Yazgan University (Turkey), Education First international education center (Italy), Alfa BK University (Serbia), National Ilan University (Taiwan), PeopleCert International Limited, Lomonosov Moscow State University, Moscow State Institute of International Relations (MGIMO), St. Petersburg State University, Samara National Research University named after academician S.P. Korolev (Samara University), Novosibirsk State Technical University, Siberian Federal University, Financial University under the Government of the Russian Federation, Russian Presidential Academy of National Economy and Public Administration, Moscow Pedagogical State University, The Pushkin State Russian Language Institute, The Maxim Gorky Literature Institute.

The total number of participants amounted to 137 people, including 12 international attendees.

Main thematic areas covered the sections below:

- Topical Issues of Teaching Foreign Language of Business Communication
- Modern Trends of Profession-Oriented Foreign Language Teaching
- Strategies Used in Teaching Profession-Oriented Translation in a Non-Linguistic University
- Intercultural Communication in the Context of Language of Business Communication
- Topical Issues of Modern Applied Linguistics (German Languages)
- Topical Issues of Modern Linguistics
- Topical Issues of Modern Teaching Methods

The papers submitted online on the conference website https://lspconference.ru/index.html were processed through Antiplagiat VUZ plagiarism detecting system. Blind peer review was aimed at selecting high-quality manuscripts with high scientific relevance, originality, and corresponding to scientific ethical standards. Each article was directed for peer review procedure to a specialist with CSc or DSc degree and professional experience closest to the topic of the article.

The peer review assessed the following criteria: relevance and originality, description of the topic, aims and objectives; adequacy of quotation and references; adequacy of data use, theoretical background; coherence of the text and correspondence to the functional style; methodology of study i.e. adequacy of methods and argumentation, precision of procedure use, completeness and relevance, manner of result presentation; results of critical analysis, logic, completeness of solutions, link between results and objects; theoretical and practical relevance of the study results and recommendations and evaluation of study restrictions. Among the 137 papers selected for the conference, 45 papers were selected for publication in the conference proceedings. 50 reviewers assessed the articles with acceptance rate of 32%.

The conference has become a platform for the exchange of views on topical issues of modern methods of teaching a foreign language for special purposes, translation and linguistics. We would like to express our sincere gratitude to the leadership of RUDN University and the organizers for their support in holding a large-scale scientific forum. We thank all participants of the conference for their active participation in the sections, round table and workshops.
